The Direct Debit Guarantee



- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits
- If there are any changes to the amount, date or frequency of your Direct Debit Elmbridge Borough Council will notify you ten working days in advance of your account being debited or as otherwise agreed. If you request Elmbridge Borough Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request
- If an error is made in the payment of your Direct Debit by Elmbridge Borough Council or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society
 - If you receive a refund you are not entitled to, you must pay it back when Elmbridge Borough Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Direct Debit

The advantages

If you have a bank or building society account, this is an easy way for you to pay and there is normally no charge for this service.

There is no need to:-

- write cheques
- buy stamps or envelopes
- wait in queues

One instruction is all it takes, and it will continue from one year to the next.

The safeguards

You are fully protected against error and, in the unlikely event of a mistake being made, your bank or building society guarantees a full refund. You will be notified of amounts due at least 10 working days in advance of payment so that you can check the details.

Payment will be collected on or shortly after your preferred date. In the unlikely event this date has to be changed you will be informed well in advance.

You may cancel your Instruction at any time by notifying your bank or building society and advising the Council.

Here's what to do...

To pay by Direct Debit just complete the instructions (overleaf) and send it (or hand it) to the Council. The instruction is simple to complete needing only:-

- certain information about your bank account (which you will find on any of your cheques)
- your signature and the date
- choose one of three different payment dates.

And finally...

The most convenient way to pay council tax is by Direct Debit. I hope you will agree to this method which will make payment easier for you and at the same time help the Council keep down costs.
