

Responsible Authorities for Elmbridge Applications under the Licensing Act 2003

This is a summary of the requirements of the Licensing Act 2003 regarding the service of applications etc. If you are in doubt about the legal requirements of that Act you should consult a legal adviser. The Council takes no responsibility for the accuracy of the information set out below which we try to keep up to date.

Who to send your application/representation/review request to

Applications, representations etc. must be sent to the Licensing Authority. It must be in writing and may not be sent by email or fax without prior agreement from us. The date of service on us will be the date when we receive the written copy or the electronic copy.

If you are submitting an application or a request for review, a complete copy of this, including plan(s), must also be sent to all the bodies, other than the Licensing Authority, listed below and these must all arrive at those authorities on the same day as the application or request for review is given to the Licensing Authority. Whilst not a legal requirement, we recommend that if you are posting these copies you send them by recorded post and retain proof of postage.

Where the document is a request for a review, a copy must also be served on the Premises Licence holder to arrive on the same day as the document is served on the Licensing Authority.
