## Parking on street policy

Please refer to the chart below that explains the contravention code and indicates circumstances where cancellation will be considered, it is important to note that this information is for guidance and that each case will be considered on its individual merits.

Circumstances in which the cancellation of a Penalty Charge Notice will be considered are marked with as 'Yes'.

Contravention codes	Blue Badge Holders will be considered if No badge/clock is displayed - fallen from windscreen, displayed incorrectly (details face down) or obscured - PCN will normally be cancelled on the first occasion only if proof of a valid Blue Badge is provided.	If Loading or unloading was being carried out, then an invoice is required to show that the vehicle was loading/ unloading, and the goods were bulky or pre- ordered.	If your vehicle broke down we require a breakdown or recovery report, documentation from a garage confirming works to fix the fault, or an invoice / receipt for parts purchased	If your vehicle was stolen a crime report and reference number are required to show that the vehicle was taken without consent.	If your ticket was facedown, not displayed, obscured. PCN will be cancelled on the first occasion, however only if provided with a copy of the valid P&D ticket.	If you have a valid permit and it had fallen, was obscured, not correctly displayed - PCN will be cancelled on the first occasion only if proof of a valid permit is provided.
