<b>Explanatory notes:</b>				
Fees are divided into 2 elements: the primary fee is payable on application and the secondary fee is payable on granting the licence.				
The primary fee is all those costs associated with determining the licence application and includes administration costs and the cost of processing any associated documentation and undertaking the initial inspection. These are recoverable along with the application.				
The secondary fee includes recoverable reasonably expected enforcement costs, including one interim compliance visit during the licence period. These are recoverable once the licence is granted. The licence will not be issued until the secondary fee is received.				
The new legislation introduces new processes such as appeals, variations and revocations. It also allows operators to request some visits such as variations, re-score visits, and appeals. Such visits costs are recoverable.				

The duration of the licence will be based on the ability of the operator to demonstrate that they meet the conditions required for that licensable activity and their compliance and management controls in place. They will be allocated a risk score and star rating based on these factors. The star rating will determine the length of the licence.

Veterinary fees where required will be charged at full cost recovery.

Reasonable costs, including any necessary compliance visits during the licence period, will be chargeable at ongoing rates.
