The Licencing Authority will then change the details on their Personal Licence and re-issue the licence. It is a criminal offence not to notify the Licensing Authority of such changes.

Note 2. This address should be the address where you will normally live **not** where you work.

Note 3. You are required to send both parts of your Personal Licence in to us with this notification form. If you cannot do so you are required to make a statement in the box provide as to why you cannot.

Note 4. Fees. We will accept payment by credit/debit card (over the phone or in person) or by cheque payable to 'Elmbridge Borough Council'.
