

THE ELMBRIDGE BOROUGH COUNCIL (OFF-STREET PARKING PLACES)

ORDER 2026

Elmbridge Borough Council, in exercise of the powers under Sections 32, 35 and Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”), the Traffic Management Act 2004 (“the 2004 Act”) and of all other Regulations and Orders made in exercise of the powers conferred by the 2004 Act and all other enabling powers, with the consent of Surrey County Council given under Section 39(3) of the 1984 Act and after consulting with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 of the 1984 Act, hereby makes the Elmbridge Borough Council (Off-Street Parking Places) Order 2026.

PART I – GENERAL

Commencement and Citation

1. This Order may be cited as the Elmbridge Borough Council (Off-Street Parking Places) Order 2026 and shall come into force on 22 June 2026.

Revocation

2. Without any effect on any obligation or liability having arisen before the making of this Order, the Orders set out in Schedule 4 are hereby revoked.

Definitions

3. (i) In this Order, except where the context otherwise requires, the following expressions shall mean:–

“Cashless Parking” means the purchase of a period of parking by using a telephone or remote electronic device to facilitate a cashless parking transaction and which records details pertaining to such payment, vehicle, parking place and parking period, without the receipt of a physical printed ticket.

“Civil Enforcement Officer” means a person authorised by the Council to supervise and enforce any off-street parking place, having the same meaning as section 76 of the 2004 Act;

“Class of Vehicle” means the types of vehicles allowed to park in a Parking Place. These are passenger vehicles, light goods vehicles and motorcycles (unless the provision in Article 10 applies).

“Charging Days and Hours” are the days and times that charges apply, in accordance with the provisions contained in Schedule 1, these exclude Christmas Day, Boxing Day, Good Friday, Easter Sunday and English Bank and Public Holidays;

“Closed” means the period when a Parking Place has signage or barricades to indicate that it is not accessible by any members of the public, by direction of the Council. For the avoidance of doubt, during the time a Parking Place is closed, it cannot be accessed by vehicles or pedestrians, unless under the authority of the Council. References to “Close” and “Closures” shall be interpreted accordingly.

“the Council” means Elmbridge Borough Council;

“Days and Hours of Operation” means the days and times that the Parking Order is in force. For the avoidance of double, this Parking Order is in force during Monday to Sunday, at all times.

“Disabled Person’s Badge” means a disabled person’s badge, including a time clock, issued by any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (as amended from time to time) or the equivalent regulations in another country;

“Driver”, in relation to a vehicle left in a Parking Place, means the person driving the vehicle at the time it was driven into and/or left in the Parking

Place and for the purposes of the Order and any legal proceedings taken thereunder if on the date a vehicle is driven into and/or left in a Parking Place a person is shown to have been the registered Owner or keeper thereof by notification from the appropriate Registration Authority that person shall be deemed to have been the Driver of the vehicle on that date unless the contrary is shown;

“Light Goods Vehicle” means a motor vehicle which is constructed or adapted solely for use for the carriage of goods or burden of any description the overall height of which does not exceed 2.44 metres and the unladen weight of which does not exceed 2540 kilogrammes, and which is not drawing a trailer;

“Handheld Device” means a device used by a Civil Enforcement Officer for verifying details of parking contraventions, recording evidence electronically and for issuing a Penalty Charge Notice;

“Maximum Height” is the restriction by means of a height restriction barrier at a Parking Place entrance / exit, physically preventing vehicles over this height from entering;

“Maximum Stay” means the longest period of time that a vehicle can continuously park in a Parking Place (except where Article 8 applies);

“Motorcycle” refers to a two wheeled mechanically propelled vehicles not having a sidecar or trailer attached;

“Owner” means the person who is recorded as the registered keeper of the vehicle by the Driver and Vehicle Licensing Agency as defined in Section 92 of the 2004 Act on the date on which the vehicle was parked in the parking place in question or the person who has the use of such vehicle in the course of their employment and is entitled to use such vehicle as if they were the registered keeper;

“Parking” in relation to a vehicle means where that vehicle is stopped for any period, whether or not the Driver or another person is present in or at the vehicle, or the engine remains running;

“Parking Bay” means an area indicated by lines marked on the surface of a Parking Place, for parking a motor vehicle within. Where the type or Class of Vehicle is specified, this is indicated by markings on the surface of the Parking Place or on a sign adjacent to the relevant Parking Bay or in the Parking Place;

“Parking Place” means an area of land provided by the Council under Section 32 of the 1984 Act for use as an off-street Parking Place as defined by s142(1) of the 1984 Act;

“Parking Payment Machine” means an apparatus located in a Parking Place for accepting payments and issuing Pay and Display Tickets,

“Passenger Vehicle” means a motor vehicle (other than a Motorcycle) constructed or adapted solely for the carriage of not more than eight passengers (exclusive of the Driver), without a trailer attached;

“Pay and Display Ticket” means a ticket issued by a Parking Payment Machine indicating the payment of the parking charge which is valid for the date and time period specified on the ticket. This includes the provision of a ticket obtained free of charge in Parking Places;

“Penalty Charge” means the charge set by the Council under Section 77 and Schedule 9 of the 2004 Act; The Penalty Charge is to be paid to the Council following the issue of a Penalty Charge Notice within the period specified on that Penalty Charge Notice;

“Penalty Charge Notice” means a notification of a Penalty Charge issued by a Civil Enforcement Officer pursuant to the provisions of Part 6 of the

2004 Act and the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

“Permit” means a paper or electronic record of a prepayment made via a telephone, smartphone, computer or other method, allowing a vehicle to park for a period of time, valid for the period specified and in the Parking Place(s) specified, following approval of an application for a permit made to the Council.

“Refund Voucher” is a ticket displayed in a vehicle allowing the vehicle to park for a day or period of time without the need to purchase a Pay and Display ticket. Where the day and/or time are written by hand, this will be by using an ink ball-point pen. Failure to complete the information or amending the information invalidates the Voucher;

“Relevant Position” means

(a) in respect of a Disabled Person’s Badge, displayed

- (i) inside the windscreen on the dashboard or fascia of the vehicle, or
- (ii) where the vehicle is not fitted with a dashboard, fascia or windscreen, in a conspicuous position on the vehicle,

and in each case so that the date of expiry, the name of the issuing authority and the serial number are clearly visible and able to be read easily from outside the vehicle, and

(b) in respect of, Pay and Display Ticket, Season Ticket, or Refund Voucher,

- (i) the Pay and Display Ticket, Season Ticket, or Refund Voucher is shown inside the windscreen, or
- (ii) in the case of a vehicle not fitted with a dashboard, fascia front windscreen the Pay and Display Ticket, Season Ticket,

or Refund Voucher is shown in a conspicuous position on the vehicle,

and in each case so that the front face and all of the information including any expiry time and date, any date of validity and any reference number is able to be read easily from outside the vehicle;

“Reserved”, in respect of a Parking Place, means not available for parking by the public, or otherwise reserved for a particular Class of Vehicle, or purpose, or a vehicle for which a specific scale of charge has been paid, or maximum period of stay applies;

“Restricted Area”, in respect of a Parking Place means any area other than a Parking Bay and where parking is not permitted;

“Season Ticket” means a ticket purchased from the Council and issued subject to the Council’s terms and conditions, valid for the period specified on the ticket and in the Parking Place(s) specified on the ticket, or electronic record where applicable;

“Suspension” means all or part of a Parking Place separated by signage or cones or markings, put in place by an authorised officer of the Council, indicating that the specified area is not for use by the public, but may be reserved for a specific use by direction of the Council.

- (ii) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (iii) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to the Article or Schedule bearing that number in this Order.
- (iv) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

- (v) Headings are for convenience only and do not affect the construction of this Order.
- (vi) Unless the context otherwise requires, words denoting the singular shall include the plural and vice versa. Words denoting persons shall include either gender, bodies corporate, unincorporated associations and partnerships.

PART II – USE OF PARKING PLACES

Designation

- 4. A Parking Place may only be used to park vehicles subject to the provisions of this Order, including conditions relating to the Classes of Vehicle in such positions, on such days, during such hours, for such periods and on payment of such charges as are specified in relation thereto in Schedule 1.

Class and position of vehicle

- 5. Where in Schedule 1, a Parking Bay is described as reserved for parking by vehicles of a specified class or purpose, or vehicles parked in a specified location, no person shall cause or permit a vehicle to park in that parking bay within the Parking Place
 - (i) unless it is of the specified class;
 - (ii) unless it is wholly within a marked Parking Bay; or
 - (iii) in a position other than that specified, in particular, that will obstruct other vehicles or pedestrians using the Parking Place, or the entrances to, and exits from, the Parking Place and any premises adjoining the Parking Place;
 - (iv) in a Restricted or Closed Area

Maximum period of stay

6. Where in Schedule 1, a Parking Place is described as available on specified days, during specified hours or for a maximum period of stay, no person shall permit a vehicle to park in that Parking Place on any day, during such hours or for any period longer than those specified and as signed at the Parking Place.

Maximum height

7. Where a Height Restriction Barrier is installed at the entrance or exit to a Parking Place, vehicles exceeding the maximum height are not permitted to enter and / or park within that Parking Place.

Period of no return

8. Where in Schedule 1, a Parking Place is described as having a period within which a vehicle may not return, no person shall cause or permit a vehicle to be parked again in that Parking Place during the time for which the vehicle is excluded from being parked again in that Parking Place.

Season Ticket and Permit

9. Season Tickets and Permits are available for use in the Parking Places as detailed in Schedule 2 subject to the following conditions:
 - (i) A person may make an application to the Council for a Season Ticket or Permit in respect of a vehicle of an allowed Class of Vehicle;
 - (ii) The Driver shall abide by the terms stipulated by the Council for the use of the Season Ticket or Permit in the published terms and conditions;
 - (iii) A Season Ticket or Permit is only valid for the vehicle and in the Parking Place(s) in respect of which it has been issued;
 - (iv) The Council may at any time require a Season Ticket or Permit holder to produce to an authorised Officer of the Council such evidence to verify any particulars or information given to them in respect of any such Season Ticket or Permit issued as they may reasonably require;

- (v) The issue of a Season Ticket or Permit following an application made to the Council, remains at the discretion of the Council.
- 10. Nothing in Article 8 shall preclude a vehicle holding a valid Season Ticket or Permit that may be displayed (if a paper permit is held) in the Relevant Position from returning to the Parking Place.

Surrender of Season Ticket

- 11. A holder of a Season Ticket on surrendering the ticket shall be entitled to a pro rata by month refund of the unexpired period, less an administration charge.
- 12. Any notice, including a Penalty Charge Notice, fixed to a vehicle in accordance with this Order shall not be removed or interfered with except by or under the authority of:
 - (i) The owner or driver of the vehicle; or
 - (ii) The Council.

Disabled Persons' Parking Bays

- 13. A vehicle, of a permitted Class of Vehicle, may park in Disabled Persons' Parking Bay free of charge provided that the Driver or a passenger present in the vehicle at the time of the use of Parking Place is the person to whom the Badge is issued; and so long as the Disabled Person's Badge is displayed in the Relevant Position.

Motorcycle Parking

- 14. Motorcycles may park free of charge in a designated Motorcycle Parking Bay in a Parking Place are not subject to Parking Charges.

Electric Vehicle Charging Bays

15. No person shall use an Electric Vehicle Charging bay, designated as such, by a sign or surface marking, for any purpose other than to charge an electric vehicle. The maximum dwell time for an electric vehicle within a designated bay is four hours. The driver of the electric vehicle is required to obtain a Pay and Display Ticket.

Power to close or suspend parking places

16. Notwithstanding the provisions of this Order, any person authorised by the Council may, by notice displayed on or near the Parking Place, close or suspend any Parking Place or part thereof for any period and may designate it or any part as reserved for use only by particular vehicles or organisations for particular purposes as approved by the Council.
17. No person shall, without written consent from the Council, cause or permit a vehicle to be parked in a Parking Place or any part thereof during such periods that the Parking Place is closed or the use is suspended, or in compliance with the particulars of the reservation.

Sale of Goods

18. No person shall, without the express written permission of the Council, use a Parking Place or vehicle within a Parking Place in connection with the promotion or sale of any articles, including the vehicle itself, to any person in or near the Parking Place or in connection with the selling or offering for hire of skill or services in any other capacity.

Other provisions

19. Any person who, in a Parking Place:
- (i) erects or places or causes or permits to be erected or placed any skip, tent, booth, stand, building, or other structure without the written consent of the Council;

- (ii) lights or causes to be lit any fire, stove or cooker;
- (iii) conducts activities that do not relate directly to the parking of a vehicle in the Parking Place under the terms of use of the Parking Place; or
- (iv) soil or defile the Parking Place, or deposit or abandon therein any rubbish or litter whatsoever;
- (v) wantonly shout or otherwise make any noise to cause disturbance or annoyance of users of the Parking Place, residents, or other occupiers of adjacent premises;

shall be liable to prosecution.

- 20. No person shall cause or permit any vehicle, trailer, caravan or other item to park in a:
 - (i) Parking Place unless it is a Class of Vehicle authorised to do so;
 - (ii) Parking Bay marked as available for a vehicle of a specific class or purpose, unless it is of that class, or has been parked for that purpose;
- 21. No person shall cause or permit the use any part of the Parking Place or a vehicle in a Parking Place without the express written permission of the Council for;
 - (i) sleeping or camping purposes;
 - (ii) cooking purposes;
 - (iii) the purpose of washing, valeting, servicing or repairing any vehicle or part thereof, other than is reasonably necessary to enable that vehicle to depart from the Parking Place, or where such activities are authorised by the Council;
 - (iv) use that Parking Place solely as a means of travel or passage between one road and another.
- 22. Any notice, including a Penalty Charge Notice, fixed to a vehicle in accordance with this Order shall not be removed or interfered with except by or under the authority of:
 - (i) The owner or driver of the vehicle; or
 - (ii) The Council.

PART III – PAYMENT FOR PARKING

Payment

No person shall cause or permit any vehicle to be parked in a Parking Place during the chargeable days and hours set out in Schedule 1 without obtaining a valid Pay and Display Ticket by completing payment of the applicable parking charge or obtaining a Pay and Display Ticket free of charge for the period allowed.

23. The Driver of a vehicle using a Parking Place shall make payment of a charge either by:
- (i) purchasing a Pay and Display Ticket upon entering the vehicle in the Parking Place; or
 - (ii) making a Cashless Parking payment at the level of charge for the period required in accordance with the scale of charges specified in Schedule 1 or otherwise varied.

Means of payment

24. The charge referred to in Article 23 shall be payable either by:
- (i) the insertion of cash or by means of a credit / debit card, making up the amount of the charge payable to the Parking Payment Machine situated in that Parking Place, or by payment to a person nominated by the Council, or other approved method of payment; or
 - (ii) a cashless prepayment made via a telephone or remote electronic device allowing a vehicle to park for a period of time.
25. The Council may introduce any form of authorised parking device to facilitate entry and exit to or from any Parking Place to facilitate payment of the Parking Charge, as shown in Schedule 1, through whatever form of payment of the charge as may be determined by the Council from time to time.

Display of ticket

26. The Driver of the vehicle shall;

- (i) display the valid Pay and Display Ticket issued on payment of the charge referred to in Article 23(i) in the Relevant Position on the vehicle in respect of which it was issued, and;
- (ii) ensure that a valid Pay and Display Ticket is obtained and displayed to cover the entire period that the vehicle intends to be parked in the Parking Place. A vehicle may not be parked with payment made to extend the stay beyond the initial time the Pay and Display Ticket has been obtained for. This includes cashless parking payments or obtaining multiple Pay and Display Tickets to extend periods of free stay beyond the terms of this Order.

Validity of Pay and Display Tickets

- 27. A Pay and Display Ticket is not transferable from one vehicle to another.
- 28. A Pay and Display Ticket is valid only in the Parking Place in which it was issued. This is defined by the reference code and/or location of the Parking Payment Machine in that Parking Place, printed on the Pay and Display Ticket.
- 29. A Cashless Parking payment is valid only in the Parking Place in which it was issued. This is defined by the reference code and/or location of the Parking Place as stated in the confirmation of payment or receipt.
- 30. Where Cashless Parking is used, any person will be required to provide evidence of full payment of their required parking period, upon request by a Civil Enforcement Officer.

Expiry of parking period

31. The parking period at a Parking Place expires where:

- (i) a Pay and Display Ticket is purchased and the time indicated on the Handheld Computer is later than the expiry time and date indicated on the Pay and Display Ticket displayed on a vehicle; or
- (ii) a Cashless Parking payment is made and the time indicated on the Handheld Computer or other device is later than the expiry time and date of the electronic record of that transaction.

32. If at the time when a vehicle is left in a Parking Place and on the nearest Parking Payment Machine in that Parking Place there is a notice placed indicating that the Parking Payment Machine is out of order, or the Parking Payment Machine displays “not in use” or a Pay and Display Ticket cannot be obtained from that Parking Payment Machine for any reason, then a Pay and Display Ticket shall be obtained from another Parking Payment Machine (where provided) or a Cashless Parking payment must be made.

33. A vehicle may not be left in a Parking Place unless a valid Pay and Display Ticket has been obtained and displayed, or a Cashless Parking prepayment made, or a Permit is held, or valid Season Ticket is displayed during the chargeable hours.

PART IV – EXEMPTIONS FROM DAILY CHARGES

34. No daily charge shall be payable in a Pay and Display Parking Place during the charging hours in respect of;
- (i) a vehicle which displays in the Relevant Position a valid Disabled Person’s Badge provided that the vehicle immediately before or after the act of parking has been used or is about to be used by the person(s) in respect of whom the Badge is issued;
 - (ii) a Motorcycle left in a Parking Bay specified for such vehicles (if any), subject to Article 14;
 - (iii) a vehicle left displaying in a Relevant Position a Season Ticket valid for that Parking Place;

- (iv) a vehicle for which a Permit is in effect or a Cashless Parking prepayment has been made.

PART V – CONTRAVENTIONS AND PENALTY CHARGES

Contravention

- 35. If a vehicle is parked in a Parking Place without complying with the requirements of this Order, a contravention shall have occurred, and a penalty charge shall be payable. A Penalty Charge Notice may then be issued and served and/or the vehicle may be removed from its location. Any and all enforcement action shall be in accordance with existing legislation and any subsequent amendments.
- 36. Where a contravention of this Order constitutes a parking contravention within the meaning of the 2004 Act, or successor legislation, the contravention shall be subject to the penalties and procedures provided for by that legislation.
- 37. Where a contravention of this Order constitutes a parking contravention within the meaning of the 2004 Act, a Penalty Charge is payable for each calendar day or part thereof that the vehicle is in contravention of this Order by the Owner and the vehicle may be removed by or on behalf of the Council in accordance with the provisions of the 2004 Act and of this Order.
- 38. A contravention of this Order which does not constitute a parking contravention under the 2004 Act, or successor legislation, is an offence under section 35A of the 1984 Act.

PART VI – REMOVAL OF VEHICLES

Relocation / removal of a vehicle

- 39. Where a Civil Enforcement Officer or other person authorised by the Council believes that a vehicle in a Parking Place is in contravention of any of the

provisions of this Order, or is left in such a manner so as to cause danger or obstruction, or has been abandoned, they may effect relocation of the position of the vehicle, or its removal to a place of safe-keeping.

40. Where the vehicle carries a registration mark the Council shall ascertain from the appropriate body the name and address of the Registered Keeper of the vehicle pursuant to the Vehicles Excise and Registration Act 1994, unless the Council is satisfied that the true owner of the vehicle has identified himself.
41. The Council shall, where it is by Part VI of this Order, aware of the name and address of a person who appears to be the owner of the vehicle, send a Notice to that person at that address stating that it is the intention of the Council to remove or otherwise dispose of that vehicle on or after a specified date (which shall not be less than two weeks from the date of the Notice and in any event no earlier than six weeks from the date of the first step taken by the Council under this Part) unless it is in the meantime removed by or on behalf of that person from such place as is specified by the Council in said Notice or from such place as may be subsequently notified in writing by the Council to that person.
42. If any person to whom a Notice is sent in accordance with this Part informs the Council of the name and address of some other person who he alleges may be the owner of the vehicle, a Notice stating the particulars shall be sent to the other person and to any further person who the Council may in consequence of the sending of the Notice to the said other person be led to believe may be the owner of the vehicle.
43. Where a vehicle does not carry a registration mark the first step to be taken by the Council shall be to apply to the Chief Officer of Police in whose area the parking place is situated enquiring whom that officer considers is the owner of the vehicle and the address of that person.
44. The Council shall then make such further enquiries as to ownership as it thinks fit.

45. In the event that the Council incurs costs in connection with the removal or disposal of the vehicle, the Council may recoup these costs from the person who was the owner of the vehicle immediately before its removal or disposal from the Parking Place, provided that that person was sent by the Council a Notice under this Part.
46. Where a Notice is required to be or may be sent to a Person under this Order, that Notice shall be sent by recorded delivery post.

PART VII OTHER PROVISIONS

Stop engine and apply brakes

47. The Driver of a vehicle using a Parking Place shall stop the engine as soon as the vehicle is in the parking space and shall not start the engine except when about to change the position of the vehicle in or to depart from the Parking Place;
48. The Driver of a vehicle using a Parking Place shall, except in the case of a Motorcycle, set or apply the braking system of the vehicle so that it prevents at least two of its wheels from revolving, or where a vehicle has three wheels or less, one of its wheels from revolving, when the vehicle is not in motion.

Road-worthy Status

49. Any person who causes or permits any vehicle to wait in a Parking Place without the vehicle being licensed in pursuance of the provisions of Section 1 of the Vehicle Excise and Registration Act 1994 and without a current policy of insurance in relation to the use of the vehicle by the driver such as complies with Part VI of the Road Traffic Act 1988 shall be liable to prosecution. For the avoidance of doubt vehicles who have been declared to be off the road by way of a Statutory Off-Road Notification to the Driver and Vehicle Licensing Agency cannot be parked in a Parking Place.

50. Any person who causes or permits any vehicle to park or wait in a Parking Place without the vehicle holding a valid MOT test certificate in accordance with section 47 of the Road Traffic Act 1988 shall be liable to prosecution

Signs

51. Where signs are erected, or surface markings laid, for the purposes of indicating the: entrance(s) to or exit(s) from a Parking Place; or specifying the direction in which vehicles are to proceed, a person shall not drive or cause any vehicle to be driven;
- (i) so that it enters the Parking Place otherwise than by an entrance, or leaves the Parking Place otherwise than by an exit;
 - (ii) in a direction other than that specified;
 - (iii) in a manner, or at a speed, so as to cause danger to any person in the Parking Place.

PART VIII – LIABILITIES / PENALTIES

52. Vehicles using the Parking Places do so at the risk of the driver and the Council accepts no liability or responsibility either at common law or under the Occupiers' Liability Act 1957 or otherwise for loss of or damage to vehicles or other property left in Parking Places.
53. Vehicles using the ramps or access roads do so at the risk of the driver and the Council accepts no liability or responsibility either at common law or under the Occupiers' Liability Act 1957 or otherwise for loss of or damage to vehicles removed or whose position is altered by towing or driving the vehicle to a place where it is not causing an obstruction.
54. Any person who, with intent to defraud, interferes with a Parking Payment Machine or operates or attempts to operate it by the insertion of objects other than undamaged and unaltered coins of UK legal tender, shall be liable to prosecution.

55. No person shall cause damage to any Council equipment, signage or lighting installations or other installations within the Parking Place or to any part of the fabric of the Parking Place and any person doing so shall be liable to prosecution.
